MORTGAGE NUMBERS HIGHEST IN TEN YEARS

Plymouth County recorded 3,043 mortgages during the month of June. "We recorded over 3,000 mortgages during June," said Register of Deeds John R. Buckley, Jr. "We have not seen this many mortgages recorded during a single month in over ten (10) years," added Register Buckley. The low interest rates have fueled the surge in mortgages. Last year at this time Plymouth County had recorded 9,219 mortgages. Thus far this year Plymouth County has recorded 14,517 mortgages, representing a 57% increase in mortgage activity!

Plymouth County Register of Deeds John R. Buckley, Jr. reported 836 sales in June. "That's the most monthly sales we have seen in 2020," noted Register Buckley. Given the Covid-19 environment this is good news. However, and not surprising, the overall number of sales thus far in 2020, are less than the recorded sales in 2019. The total sales volume for 2020 year-to-date trails 2019 sales by 12%. Thus far in 2020, there have been 4,075 sales in Plymouth County, compared to 4,628 sales for the same time period in 2019.

The emergency legislation suspending most foreclosures brought on by the pandemic has brought this activity to a virtual standstill. Plymouth County recorded 5 foreclosure deeds in June. Year-to-date there have been 108 foreclosure deeds recorded compared to the 140 foreclosure deeds recorded through June, 2019. This amounts to a 23% decline in foreclosure recordings.

There were zero notices initiating a new foreclosure recorded in June, compared to 66 notices that were recorded in June, 2019. Thus far this year there have been 202 foreclosure notices recorded, compared to the 368 foreclosure notices recorded through June, 2019. This represents a 45% decline in recordings.

As part of our ongoing effort to share with the public some of America's oldest records, and recognizing the limitations in place due to the coronavirus, we are attaching a copy of an original land record for one of the earliest mortgages recorded in our country, a mortgage that had a different kind of security. On May 27, 1639, Mr. John Combe mortgaged "one browne cow called Berry, which was sent him out of England"

to Mr. Thomas Prence to secure the repayment of monies loaned to him. This "browne cowe" was previously mortgaged and released by Mr. Prence upon Combe's repayment of an earlier debt. Plymouth Colony Records; Court Orders, Vol. 1, p. 200. Upon hearing of this loan transaction, one of our prominent local bankers inquired whether this was one of the first "used cow loans" When conditions permit we will resume our monthly display of these wonderful and historic documents in the Plymouth Colony Records Reading Room here at the Registry of Deeds.
