Re: Plymouth County Registry of Deeds Fee Schedule as of 12/31/2019

The Massachusetts Fiscal 2020 Budget includes increases in fees collected at the Registries of Deeds to provide additional revenues for the state Community Preservation Act Trust Fund.

Section 29. Section 8 of chapter 44B of the General Laws is hereby amended ... by striking out in lines 3, 8 and 23, the figure "\$20" and inserting in place thereof, in each instance, the following figure:-\$50."

Section 30. Said section 8 of said chapter 44B ... is further amended by striking out, in lines 10,14 and 24, the figure "\$10" and inserting in place thereof, in each instance, the following figure:-\$25."

The fees (including all surcharges) for recording or registering a document in the Plymouth Registry of Deeds or the Plymouth Registration District of the Land Court, effective December 31, 2019, are as follows:

Transfer Excise Taxes remain the same: \$4.56/\$1,000.00 of stated Deed consideration.
